

Dear Customer, Thank you for contacting us.

During your stay II Borgo Mulino d'Acqua offers various activities to do in nature: Padel court, soccer field, beach volleyball, ping-pong, semi-Olympic swimming pool, hiking or cycling excursions, walks and runs, horseback riding and underwater excursions, some of which can be done on site and others a few km away from the property.

Our dining area is large so as to leave plenty of room for action and free space, breakfast and lunch will be strictly outdoors.

Our accommodations are distributed within a large park, spaced apart from each other to ensure privacy and security.

The structure is located close to the State Property, it overlooks the sea but does not have access to the bay below.

#### Mandatory paid services:

- 15 days before arrival at the property, the Client is required to pay a security deposit of € 100.00 (via pre-authorization on a credit card) as a guarantee for any damage to the accommodation and/or extraordinary cleaning costs. The Client is invited to carefully read art. 3 of our Regulations.
- Tourist tax (\*) The Municipality of Otranto applies a tourist tax of € 1.50 per day for the first 5 days of stay. Children up to 12 years are exempt. (Rate subject to change)

#### CHECK-IN CHECK-OUT PROVISIONS:

- The customer can access the facility starting from 9:00 and use the services.
- The accommodations will be delivered from 5:00 pm on the day of arrival. The Client must leave the accommodation no later than 10:00 am on the day of departure, but may continue to use the services available within the structure until 8:00 pm
- For arrivals after 20:00 there is a supplement of € 50.00, to be paid upon arrival at the facility. In any case, arrivals after 22:00 are not permitted.

#### RATE CONDITIONS:

- To confirm the reservation, it is necessary to pay 40% of the total cost of the reservation as a confirmation deposit, the payment of the same is considered as acceptance of the regulations and all the provisions and special conditions of the Structure. In addition, to confirm the reservation, it is required to fill out the form that we will send together with the estimate necessary to receive all the data of the members of the guests.
- Payment of the entire stay is required within 48 hours prior to arrival at the property.
- Cancellations are accepted exclusively by registered mail, if received within 60 days of the arrival date indicated in the booking confirmation, the Customer will be entitled to a refund of 50% of the deposit sent; in the event of failure or late communication of the cancellation in the manner and within the times indicated in this regulation, the Customer will not be given any refund.
- Payment methods: cash, credit cards (all except American Express), debit cards, prepaid cards. Bank checks are not accepted

**NO SHOW**: In case of no show the property will apply a penalty equal to the total amount of the confirmation deposit previously paid.

#### ADDITIONAL INFORMATION:

- <u>Smoking is prohibited in all internal areas of the Borgo Mulino d'Acqua property.(art. 51 law n. 3 of 16/01/03 and of the Prime Ministerial Decree of 23/12/03</u>



- The property is approximately 1.5 km from the city beaches of the center of Otranto, while the Alimini beaches are approximately 3 km away.
- During the season, the Management will have the right to organize special events (parties, concerts, after hours or other) that may continue beyond midnight until late at night.
- The structure is located close to the state-owned area and allows only to enjoy the sea view, without being able to go near the cliff.
- Only small pets are allowed (max 7 kg) €12.00 per day and are welcome with a few small restrictions: no access to sports and commercial areas and the swimming pool solarium.
